2. Approval of the New Delhi meeting minutes

ISCARSAH New Delhi Meeting Minutes of 9 December 2017 were approved by the meeting participants.

3. ISCARSAH Training Course to be held in IRAN in October

The syllabus for the proposed 3 day training course has been well developed through a small group of editors on the iscarsah Bureau.

There was some discussion whether the call for instructors for this training course was widely disseminated. At the time of this meeting there were only three volunteers. After much discussion it was determined that the call for instructors was adequately disseminated through the listserv.

President Arun will reach out to the membership to find more instructors.

4. Task Group on ISCARSAH Guidelines

Expert member **Pere Roca**, chair of this task group, has composed a first draft of the ISCARSAH guidelines for review. Members of the iscarsah get guidelines subcommittee include Maria Margarita Segarra-Lagunas; Androniki Miltiadou-Fezans; Daniel Torrealva; Wolfgram Jäger; and Donald Friedman. The draft guidelines were distributed to participants prior to the meeting.

It was agreed by all that this is an extraordinary document. The following comments were received.

Skłodowski suggested that long-term monitoring (controls) be added.

Humo made the following suggestions:

- Add a check list at the end of the document
- Have a more detail on the explanatory report in order to present work clearly to the client. Explanatory report should also be placed at the beginning of the document.
- The Guidelines should help with country codes concerning seismic issues
- Page 7 historical research – use the term “historic” rather than “ historical”
- Section 4.5 – who is to judge about what is low, medium or high intervention?

Humo submitted a hand-written mark up of his review of the document that has been provided to Chairman Roca.

Rihal commented that the draft guidelines are a great document and very rigorous. He offered the following comments:

- Monitoring is extremely important.
- Nonstructural components should also be included because they become damaged and cause damage during seismic events.
- An experience and knowledge base should be established
- Patterns of damage caused by natural actions are very important and would be a welcome addition to the guidelines.

Sofronie commented that this is a dynamic area that needs continuing renewal, and the guidelines will need to be continuously revised.

Özata suggested that the guidelines refer to the use of local masters and craftsmen and lessons learned.

It was noted that all members of this task group are academicians. Practitioners Mustafa whom all and Stephen Kelley have volunteered to become members of this task group.

5. Expert Member Database

President Arun stated that only 35 members have submitted their credentials to the expert database. Secretary-General Kelley stated that he would reach out to the membership to try to receive greater response.
